



2024 PBFIT \$30K RIDE & SLIDE SPECTACULAR

BetterBody Foods, owner of the PBfit Brand, has partnered with GWRHA to host the **PBfit \$30K Ride & Slide Spectacular!** It will be structured like the Run For A Million in that there will be two qualifier classes, one at the Best Little Derby in the West (BLDW) in May and one at The Knockout World Premier Reining Event (TKO) in June. The top 8 riders from each qualifier (plus ties) will be eligible to compete in the **PBfit \$30K Ride & Slide Spectacular** held at the Low Roller Reining Classic in October. All 3 shows are located at the Idaho Horse Park in Nampa, Idaho. You can enter multiple horses in the qualifying class; however, riders will qualify only once. Riders are not required to compete in the **PBfit \$30K Ride & Slide Spectacular** on the same horse they qualified on. Non-Pro riders may ride horses not owned by themselves (it's an open class) but must follow NRHA non pro rules in accordance with the NRHA Handbook (i.e. entry fees and/or show-related expenses must be paid by the non-pro or others as allowed via the NRHA Handbook, etc.). There will be no entry fee or judges fee for those qualified to compete in the **PBfit \$30K Ride & Slide Spectacular** in October. All 16 finishers will receive a payout, with the winner guaranteed at least **\$10,000!** PBfit and GWRHA are anticipating lots of participation with the hopes of expanding the purse in future years. We will also be adding two side events, **PBfit Longest Slide** and the **PBfit Spectacular Spin**, with at least \$1,000 to the winners. More to come on how to qualify for these events.

QUALIFICATION: The top 8 finishers (plus ties) from each qualifier will move on to the **PBfit \$30k Ride & Slide Spectacular**.

- 1) BLDW—A NRHA Category 1 Open class (\$5,000 PBfit Reining Open Class) will run concurrent with the Open Derby on Saturday, May 11th. This allows all the Derby horses the opportunity to cross enter this qualifier class with one run; this open class is also available to those horses that may no longer be of derby age. This class is open to all riders and horses, is NRHA approved, and will pay out in accordance with schedule B.
- 2) TKO—A qualifier class will run concurrent with the Slate #1 Open classes on Saturday, June 8th (\$20k Open, \$15k Intermediate Open, \$500 Rookie Pro, and \$500 Limited Open). The entry fee for this qualifier class is \$150 and will be retained by show management. No prize money will be offered in this qualifier class and is not NRHA approved but do fall under the same rules and regulations. You must be entered in at least one of the other 4 open classes.

CRITERIA:

- 1) Rider can enter multiple horses in a qualifier class, but only qualify for one position at the **PBfit \$30K Ride & Slide Spectacular** in October. Should one rider finish in the top 8 with multiple horses, their one slot is secured, and the next placing(s) will move up.
- 2) Entry Fees apply to the qualifier classes, but there will be NO Entry Fee or Judges Fee for the Final in October.
- 3) Rider is not required to ride the same horse they qualified on.
- 4) All NRHA rules apply including membership and competition licenses.
- 5) These are Open classes and Non-Pro riders may compete without ownership restrictions normally invoked with Non Pro classes. However, note that there are other NRHA Non-Pro conditions that do apply (i.e., the Non-Pro rider must pay their own entry fees, they may not receive remuneration outside normal payouts, etc.). See the NRHA Handbook for complete details.
- 6) Payout at the **PBfit \$30K Ride & Slide Spectacular** is unique, paying out all 16 places and at least \$10,000 to the winner, with a total purse of \$30,000. The **PBfit \$30K Ride & Slide Spectacular**, in October, is an NRHA Category 11 class, restricted to only those who have qualified. Money earned in this class will not count towards World Champion and Top Ten awards but are included in horse and rider lifetime earnings.
